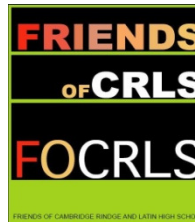

<p><u>Description:</u> A two-year scholarship, \$500 for each of the next two consecutive years of college</p>
<p><u>Eligibility:</u></p> <ul style="list-style-type: none"> <li>• Candidate must be a CRLS graduate</li> <li>• Candidate must have passed the Accuplacer Examination (achieved placement in college-level courses on all three exams) by June 1, 2014, or otherwise placed out of all developmental courses at their college.</li> <li>• Candidate must be in good academic standing at the college in which they are enrolled.</li> <li>• Candidate must demonstrate financial need (see "additional materials" below). The candidate must be enrolled in an accredited Massachusetts public 2- or 4-yr. college or university in the fall. Preference given to students enrolled at University of Massachusetts/Boston or Bunker Hill Community College.</li> </ul> <p>Note: Applications for this scholarship will be accepted on a rolling basis up to September 1, 2014, or until both have been awarded.</p>
<p><u>Award Decisions</u>  FOCRLS It Takes a Village (ITAV) Advisory Committee reviews all applications and makes the final decision of awardees. The ITAV Advisory Committee will consider multiple criteria by which the sponsor can assess financial need, including: FAFSA, adjusted gross income through Federal income tax forms, recipient of food stamps, resident in public or Section 8 housing</p>
<p><u>Payment method:</u> Check to be presented in person to student, once all eligibility criteria are confirmed and release form (FERPA) is signed.</p>
<p><u>Award Terms and Conditions:</u>  To continue with second year funding of \$500,</p> <ul style="list-style-type: none"> <li>• ITAV Scholars must submit her/his previous year's college transcript, showing evidence of enrollment of semester to semester enrollment</li> <li>• ITAV Scholars must maintain at least a "C" average</li> <li>• ITAV Scholars must be in good academic standing at their college or university</li> </ul>
<p><u>Renewal Process</u></p> <ul style="list-style-type: none"> <li>• ITAV Scholars must submit his/her previous year's college transcript and complete a Year-End survey to receive funding in Year 2.</li> </ul>
<p><u>Withdrawal policy</u></p> <ul style="list-style-type: none"> <li>• If a scholar withdraws on or after classes begin, funding will not be awarded.</li> </ul>
