#### FROM THE PRESIDENT

## An Important Year of Change and Growth

Dear Friends,

As the new President of Friends of CRLS, it is my pleasure to invite you to read our 9<sup>th</sup> Annual Report, the story of an important year of change and growth.

In many ways change and growth has been a constant for FoCRLS. Founded in December 2006, with the mission of supporting academic and social development at CRLS, in its first year, FoCRLS raised \$4,743 and launched its first two programs—Faculty Innovation Grants and Faculty Distinction Awards. Nine years later, in 2014/2015, FoCRLS raised over \$130,000 to support a broad array of programs—including Faculty Innovation Grants, Student Travel Fellowships, Faculty Distinction Awards, Unsung Heroes Student Awards, Scholarships, and the "It Takes a Village" College Success Program, in order to expand opportunities for all CRLS students, and allow all students to reach their potential. The growth of our scholarship program is an area of particular pride. In 2015, FoCRLS presented 24 scholarships and awards totaling \$24,700 to graduating seniors, both funded by FoCRLS and others created by community members under the FoCRLS umbrella.

This progress came thanks to the engagement of many—parents, alumni, business owners, and Cambridge community members at large. The beaming faces of students—on Scholarship night, receiving an Unsung Hero award, or recounting the trip of a lifetime that they were able to take because of a Student Travel Fellowship—the enthusiasm of teachers reporting back on their Faculty Innovation Grant projects that provided new opportunities to students, and the support of those who made it happen, all these things made the year special.

But 2015 was also the year of a special kind of change and growth for FoCRLS, as we took key steps to ensure our ability to continue to serve as a resource for CRLS students well into the future. The first was the hiring of an Executive Director. As part of the FoCRLS strategic plan process, the Board determined that having leadership-level staff person was a critical element for long-term sustainability. The Board underwent an intensive open search process, and came to the decision to select Elaine Schear, former FoCRLS President and one of the FoCRLS cofounders, as its choice to take the helm of FoCRLS as its first Executive Director as of January 2015. As you will read in the pages ahead, Elaine hit the ground running, launching the "100 by 100" Cambridge Business Community Scholarship Initiative to great success. A second important step was the creation of a FoCRLS investment policy for scholarship funds, to make sure that these funds entrusted to FoCRLS would be handled responsibly and transparently, and would grow as a resource.

Such organizational changes are not glamorous, but are deeply important. We believe that FoCRLS came out of the year 2014/2015 stronger than it entered it. We are grateful for the support and trust of the Cambridge community, and look forward to working with you in the year and years ahead to continue to expand opportunities for all of our students.

#### MISSION

The mission of Friends of Cambridge Rindge and Latin School (FoCRLS) is to develop, support, and enrich the academic and social development programs at Cambridge Rindge and Latin School and to support the alumni of CRLS and its predecessor schools. In so doing, FoCRLS promotes achievement and a greater community investment in the future of CRLS, its current students, and its graduates.

#### **EXECUTIVE SUMMARY**

During 2014/15, our ninth fiscal year, Friends of Cambridge Rindge and Latin School (FoCRLS) raised \$130,702 primarily in donations from CRLS families, Cambridge/corporate businesses, foundations, alumni, and generous community members, bringing the grand total of our funds raised so far to over \$550K!

Accomplishments of Friends of CRLS during the past year include:

- **Faculty Innovation Grants** of up to \$1,000 each were awarded to 12 teachers and staff for projects to enrich course and extracurricular activities and augment services.
- Unsung Heroes awards, funded by FoCRLS and administered by the CRLS Deans of Students, were presented to 16 emerging student achievers each term for their efforts in citizenship, stewardship, gains in attendance, athletic leadership, academic improvement, and contributions to a positive school climate, bringing the current total to 416 Heroes.
- Student Travel Fellowships were awarded to 4 students for a service and learning trip to El Salvador (in partnership with City Links), participation in the Model UN in New York City, and an environmental learning trip to the Galapagos Islands.
- Faculty Distinction Awards were presented on the graduation stage to four teachers and staff members nominated by seniors for their positive influence on students' experience at CRLS.
- The "It Takes a Village" College Success Program (ITAV) had a very active year, which saw the creation of the training program for its Mentoring Program component and the start of mentor/mentee recruitment and the launch of the ITAV College Coach program which proved to be so successful that it was taken on by UMass-Boston.
- **Scholarships** totaling \$24,700 were awarded via Friends of CRLS in 2015, a significant dollar increase of 63% over the previous year.
- The "100 by 100" Cambridge Business Community Scholarship Initiative launched, with the goal of raising \$10,000 or more annually from local businesses.
- The position of **Executive Director**, a key element of the Friends of CRLS FY2014-FY2016 strategic plan, was created with the hiring of Elaine Schear in this role.

#### **GOVERNANCE**

The year 2014/2015 was one of great change for FoCRLS with the hiring of FoCRLS first Executive Director, Elaine Schear, FoCRLS co-founder and then-President. The hiring of an Executive Director was a key element in the Board's strategic plan for long-term sustainability for the organization, previously wholly volunteer-led. This was an intensive process, involving drawing up the job description, reaching out to key community players, conducting an open search, and a two-tiered set of candidate interviews, involving both the FoCRLS Board and other stakeholders.

As part of that process, the Board analyzed those elements of Board responsibility that should remain with the Board, and those that would be taken on as part of this new staff leadership role. This has been a very energizing process, with the FoCRLS Board not only remaining the body for planning and oversight, but with Board members expanding their engagement in fundraising, program-building, and outreach.

Elaine Schear's hire as Executive Director brought with it changes in Board leadership, with former FoCRLS Treasurer Jamie Sabino, who led the organization through its strategic planning process, stepping up to serve as President, and Board member Neil Rosenburg stepped up to take on the position of Treasurer, bringing his vast experience as Director of Finance at UMass Boston to bear on FoCRLS finances.

The end of the year brought another milestone with the stepping down of Donna Spiegelman, from the Board. As one of the two co-founders of the organization, Donna dedicated countless hours into building Friends of CRLS as a resource that would serve our students. Donna served as the organization's first President, then Treasurer, and then for many years as a member of the Board. Donna visioned and created FoCRLS' innovative "It Takes a Village" College Success Program (ITAV), first launched in 2011, and served as the ITAV Program Director until June 2015. The FoCRLS Board honored Donna Spiegelman and her accomplishments at the 2015/16 Annual Meeting.

Also stepping down in 2015/2016 was Board member Sandra Lima, CRLS '98, who contributed to FoCRLS in a variety of ways, including coordinating two alumni gatherings & raffle events at Flatbread Pizza in 2013 and 2014. In spearheading these events, Sandra raised \$2,200 for FoCRLS programs while providing networking opportunities for alumni. We wish her the best and look forward to her continued involvement in FoCRLS.

### BOARD OF DIRECTORS - 2014/2015

Jamie Sabino (Treasurer—Jul.-Dec. 2014, President—Jan.-Jun. 2015) is a parent of a CRLS Class of '14 grad. Jamie served as Treasurer since 2011. Upon the selection of Elaine Schear by the Board to serve as Executive Director, Jamie was elected by the Board in the role of FoCRLS President. Jamie has been also been active on the CRLS Arts Committee. Previously, she served as president of Friends of King Open. An attorney, Jamie is a partner in Klibaner & Sabino and a consulting attorney for Mass. Law Reform Institute on issues of family law and domestic violence.

**Neil Rosenburg** (Treasurer—Jan.-June 2015; FoCRLS Scholarship Committee Chair) is an alumnus of Cambridge High and Latin School (Class of '76) and a parent of a CRLS alum (Class of '12). Neil is Director of Capital Finance at the University of Massachusetts Boston and has extensive experience on boards of several nonprofit organizations. Since 2008, he has involved himself in FoCRLS with particular emphasis on publicity, fundraising and helping to develop partnerships for "It Takes a Village." He is currently active in the expansion of the FoCRLS scholarship fund. In 2014, Neil established the Mary Frances Monti Scholarship in honor of his mother, awarded to a student demonstrating academic and personal growth.

**Elizabeth Vernon** (Secretary) has a doctorate in Library Administration and is Lee M. Friedman Judaica Technical Services Librarian in the Harvard College Library at Harvard University. She has over two decades of experience as a data management and database design consultant, including extensive pro bono work with nonprofit organizations. Elizabeth established the FoCRLS database system and provides data management training and advice to FoCRLS staff.

**Dawn Baxter** (Board), Dawn Baxter is the parent of a CRLS senior and an 8th grader at Cambridge Street Upper School (CSUS). She was an active member of the Cambridgeport School community for many years and currently serves on the School Council at CSUS. Dawn works as an independent consultant to public and nonprofit agencies in the health and human services arena, focusing on planning, communications and research. She holds an MBA from Columbia Business School.

**Ted Darling** (Board), an extremely active alumnus of the Rindge Technical School (Class of '72), served as President of the Rindge Alumni Association for three years and has been Executive Secretary since 1995. Since 1983, Ted has served as Treasurer of the John Wood Scholarship Fund and since 2011, as Treasurer of the Cambridge Athletic Hall of Fame. Ted was inducted into the Cambridge Alumni Association Hall of Fame in 1996 and the Rindge Alumni Hall of Fame in 2003. He was Rindge Man of the Year in 1988, and a Rindge Conference was named after him in 2002. Ted is a member of FoCRLS' "It Takes a Village" College Success Program Advisory Committee.

Victoria Harris (Board and FoCRLS Business Community Outreach Coordinator) is a parent of two CRLS students, Classes of '15 and '17. Victoria serves as the Learning Community C representative on the CRLS School Council and as a member of the CRLS Arts Committee and Friends of the Peabody School. She earned Masters' Degrees in social work and public health

from Boston University and currently works in project management and evaluation. As the FoCRLS Business Community Outreach Coordinator, Victoria reaches out to business leaders to explore partnerships in which both CRLS and the businesses can benefit.

Marguerite Hicks-Gyewu (Board) is a parent of a current CRLS student, Class of '16 and a CPS seventh grader. She is the Family Liaison at the Martin Luther King Jr. School, teaches first grade at Horizons National, and has had an extensive teaching history in early childhood education. Marguerite recently established The Calvin Hicks Award for Music Study in memory of her father. She is a graduate of CRLS's Pilot School (Class of '84), Mass College of Art, and Cambridge College. She serves as a member of the FoCRLS Scholarship Committee and has served on the Faculty Innovation Grants Committee.

Paula Paris (Board) is an alumna of Cambridge High and Latin School (Class of '74) and a parent of a CRLS alum (Class of '01). Paula is a co-chair of the CRLS Alumni Association and a member of the "It Takes a Village" Advisory Committee. She is the Deputy Director of JFYNetWorks and has been Development Chair and President of Brandeis's Heller School Alumni Board. She is currently a Trustee of Cambridge Health Alliance and has volunteered with the Boston Women's Fund, Cambridge Historical Society, Cambridge Arts Council, and Cambridge Montessori School. Paula holds a Master of Management in Human Services from Brandeis and Bachelor of Music from the University of Hartford.

**Damon Smith,** (Board, *Ex Officio*) is the Principal of Cambridge Rindge and Latin School. Damon was previously Dean of Curriculum at CRLS for 6 years and has served as coordinator of the History Department and advisor to the CRLS Environmental Action Club. Known among students, faculty, and families for his accessibility, Damon is an insightful leader who brings new programs and best practices to the high school. A native of New York City, graduate of Wesleyan University and the Harvard Graduate School of Education, and the son of public school teachers, Damon Smith has a strong history as a successful educator.

**Donna Spiegelman** (Board and FoCRLS "It Takes a Village" College Success Program Director) is Professor of Epidemiologic Methods at the Harvard School of Public Health in the Departments of Epidemiology, Biostatistics, Nutrition, and Global Health. She is Chair Emerita of the Boston Chapter of J Street. As a co-founder of FoCRLS, she served as the organization's first President and later as Treasurer. She served as the FoCRLS "It Takes a Village" Program Director and Chair of the "It Takes a Village" Advisory Committee through June 2015. She is a parent of two CRLS alumnae, Classes of '10 and '14.

**David Vogel** (Board and FoCRLS Alumni Outreach Coordinator) is an alumnus of Cambridge High and Latin School (Class of '74) and parent of 4 graduates of CRLS. David is a co-chair of the CRLS Alumni Association and a member of the "It Takes a Village" Advisory Committee. He lectures in the Psychology Department at Merrimack College and has a private practice as a Forensic Mental Health Consultant. David has been President of the Burn Survivors of New England since 2009. He joined the FoCRLS Board in 2011, served on the steering and advisory committees of Celebrate CRLS, and now focuses on alumni relations.

## **STAFF**

The work of Friends of CRLS volunteers is supported by a small but talented and dedicated staff. This year saw a major milestone for the organization, with the hiring of Elaine Schear as Friends of CRLS' first Executive Director, officially starting in January 2015. Hiring an Executive Director was a key element in the organization's strategic plan to build long-term sustainability.



Elaine Schear, Ed.D., the FoCRLS Executive Director, is co-founder of FoCRLS and the organization's first Treasurer and later its President. Elaine's career spans public school teaching, faculty positions in teacher education at Emmanuel and Wheelock; Director of Roxbury Community College's Teaching-Learning Center; and social work in juvenile services at Roxbury District Court, and instructor of writing at area colleges and universities. She is a recipient of the Cambridge School Volunteers Mack Davis Award for excellence in tutoring at CRLS and a recipient of the

Cambridge NAACP Education Award, along with Donna Spiegelman, co-founders of FoCRLS, for their work promoting equity. Elaine is the parent of two CRLS alumnae, Classes of '10 and '14. As Executive Director, Elaine interfaces on behalf of FoCRLS within and outside of CRLS. She oversees FoCRLS programs, works closely with the Board of Directors and with the Administrative Coordinator, and has major responsibility for fundraising, daily operations, and community engagement.



Janis Navikas, the FoCRLS Administrative Coordinator, is a graduate of CRLS (Class of '83) and UMass Boston (College of Public and Community Service, Class of '03). Janis is a native Cantabridgian. Her employment history includes nine years as the Administrative Assistant of Cambridge-Ellis School. Janis is a long-time volunteer working with animals, currently at the MSPCA. As Administrative Coordinator Janis manages the FoCRLS office, and supports the organization in myriad ways, including database management, correspondence, and design and preparation of event and meeting materials.



Rachel Deleveaux, a CRLS alumna (Class of '97) who holds an M. Ed. in Educational Administration from Suffolk University, serves as ITAV Mentoring Coordinator. Formerly both a mentee and a mentor, Rachel has worked on developing the mentor/mentee training program and recruiting mentees and mentors for ITAV. In FY2015, in addition to working with ITAV, Rachel was director of the City of Cambridge's Moore Youth Center.



Kwame Dance, who served as "It Takes a Village" College Coach (September 2014-March 2015), is a graduate of CRLS (Class of '02) and Trinity College (Hartford, CT). From 2012 to 2015, Kwame also held the position of Program Director of the Willis D. Moore Youth Center. Kwame serves on several boards, including Cambridge Alumni Association, Cambridge Football Alumni Association, Cambridge Community Center, and the City of Cambridge Civic Unity Committee.

#### **FOCRLS PROGRAMS**

Friends of CRLS offers six programs providing opportunities to CRLS faculty, students, and graduates:

## **Faculty Innovation Grants**

Faculty Innovation Grants comprise the FoCRLS flagship program first developed in 2007. To date, 151 faculty and staff have received grants. The Faculty Innovation Grants enhance curriculum, enrich activities, augment services, and encourage innovation among diverse programs and students of many different capacities, talents, and interests.

Faculty grant proposals are requested school-wide in the fall, followed by the convening of a review committee composed of CRLS parents, FoCRLS volunteers, and community members closely connected to, but not employed by, CPSD.

Faculty Innovation Grants awardees are required to submit evaluation and financial reporting materials developed by FoCRLS. Evaluations written with the input of students, along with digital photos and videos illustrating the project, are particularly encouraged.

Eleven grants of up to \$1,000 were awarded in Fall 2014 to the faculty listed below to support individually-led and collaborative projects. A total of \$8,144 was disbursed among grant-funded projects reflecting a broad range of disciplines and creative leadership. Additionally, FoCRLS Executive Director Elaine Schear worked closely with CRLS Principal Damon Smith to access school funding for several more proposals.

## **Unsung Heroes**

The Unsung Heroes program, begun in 2007, recognizes emerging student achievers whose progress and efforts may go unnoticed – if it were not for the vigilance of deans of students, counselors, and teachers. Criteria for recognition include but are not limited to academic accomplishment and athletic leadership, citizenship, stewardship, gains in attendance, academic improvement, and contributions to a positive school climate. Students may be recognized for going beyond their personal best as students, for helping a classmate in distress,

or for services they perform within or outside of CRLS. Heroes' names are displayed in each learning community on perpetual plaques made possible by the FoCRLS partnership.

A total of 416 Unsung Heroes were recognized to through the end of academic year 2014/2015. Each term, 16 are chosen: one from each of four Learning Communities, from each of four grades, along with 4 seniors honored at a pre-graduation senior breakfasts. In what has become a tradition, awardees are presented with certificates and customized watches with the CRLS Falcon logo during a breakfast presentation attended by family members and key staff from each learning community.

## **Student Travel Fellowships**

Since 2010 FoCRLS has played a part in sending students who would otherwise not be able to participate, on journeys to domestic and distant lands for life-changing adventures in learning. These trips, authorized by CRLS and Cambridge Public Schools, are opportunities for students to see fascinating places, volunteer with members of the global community, and participate in experiences that open their eyes and broaden their minds.

Because many students lack the financial resources needed to participate in these trips, FoCRLS sponsors Student Travel Fellows. In addition to meeting family income criteria, prospective fellows must raise part of the funds for the trip themselves, have at least a B average, complete a thoughtful application, and submit letters of recommendation. This year, FoCRLS awarded \$9,529 in Student Travel Fellows, supporting travel by 15 students.

An exciting element of this Student vear's Travel Fellowships program was a gratifying partnership. FoCRLS joined the CRLS Bilingual Department and City Links, an extensive multi-service program for immigrant new youth by Cambridge overseen Community Services (CCS), in supporting 13 of the 15 CRLS students now on a CRLS/CCS service learning trip to El Salvador, June 19 through July 1. The travelers participated in an extensive roster of service activities, ranging from assisting with English at an elementary school

helping with reforestation of a mangrove. The applicants, including students from Haiti, Togo, Ethiopia, the U.S., and more, met every one of FoCRLS requirements for academics, recommendations, and income. Each student received \$550-600—nearly half of the \$1,350 cost per student. The rest of their expenses were covered by a combination of their own contributions, CCS funds, and fundraising events, including an international dinner and celebration. Not only does this joint adventure make possible an extraordinary experience for a large group of students, but it also marks a partnership between FoCRLS and CCS to expand opportunities for CRLS students.

In addition, Friends of CRLS was able to provide travel grants to two other students for high impact trips, one to participate in the Galapagos Island trip, and the other to attend the Model UN in New York City.

The Galapagos Islands trip was an unforgettable experience that I will cherish for years to come. While learning about the environment and wildlife of Ecuador, I also learned the values and morals of its people, which I choose to follow daily now. The wisdom of Ecuador's natives and the extreme care and pride they have in their daily lives is something I hugely admire. I hope to one day pursue my new found love of Spanish culture and hopefully see the Galapagos again, this time with a new view.

## **Faculty Distinction Awards**

The Class of 2015 chose four beloved and admired CRLS staff members to honor at their graduation on June 4 as those who made the most impact on their years at CRLS. This was the ninth year Friends of CRLS has sponsored the Faculty Distinction Awards, bringing the total of honorees to so far 36. The 2015 Faculty Distinction Awards honorees:

**Aral Lecorps** is a native of Haiti who migrated to the United States in 1974. He has lived in Massachusetts since 1977 and is married with three children. Since 1992, Aral has been a Security Specialist at Cambridge Rindge and Latin High School, assuring the school buildings are safe for staff and students. He enjoys communicating the value of education and providing words of encouragement to CRLS students.

Janet O'Reilly, who teaches freshman algebra at CRLS, received her Masters of Education degree from Lesley University. She is academic advisor to the CRLS Boys' Basketball Team and advisor to the Step Team, for which she has received Faculty Innovation Grant funding from FoCRLS. She has worked for Teach for America Corps in Baltimore, Maryland. From this experience, Ms. O'Reilly learned that no matter how challenging life may be for many children, the love of learning and feeling smart prevails and must be nourished.

**Dr. Kimberly N. Parker**, who teaches English at CRLS, is a graduate of Colby College. She holds an M.Ed. in Secondary English Teaching from Boston College and a Ph.D. from the University of

Illinois-Urbana Champaign. Dr. Parker, who is the current President of the National Council of Teachers of English (NCTE), publishes in the area of improving the literacy outcomes for young people. She is the recipient of two FoCRLS Faculty Innovation Grants for projects adding dimension to her English Language Arts classes at CRLS.



**Greg Racki** is a psychology and history teacher finishing his first year at CRLS and his sixth year in the profession. He holds a law degree from Boston University and practiced for three years before deciding to pursue his passion and become a teacher. He has no regrets.

## "It Takes a Village" College Success Program (ITAV)

The "It Takes a Village" College Success Program (ITAV), which aims to maximize CRLS graduates' college achievement, particularly low-income students attending Massachusetts public and community colleges, entered its fourth year, made possible in part by grants in FY2014 from the Cambridge-Agassiz-Harvard Fund and the City of Cambridge. The ITAV program has been a multi-pronged one, attempting to address the different challenges to college success via different initiatives, including the Accuplacer college placement exam preparation, college coaching, career mentoring, and scholarships. The ITAV Program benefitted from the guidance of an Advisory Committee and is an active participant in the Cambridge College Success Initiative.

This was an exciting year for the ITAV program, which proved itself to be a successful program incubator. The results of the Accuplacer college exam preparation workshop held at CRLS in conjunction with the JFYNetWorks in June 2013 and June 2014 proved the need for and value of Accuplacer exam preparation to the CRLS administration, so that CRLS now administers Accuplacer exam preparation during the school year. The FoCRLS ITAV College Coach program similarly proved its worth, leading to the decision of UMass Boston and the City of Cambridge to take it on and fund it, incorporating it into the UMass Boston college coaching program.

Academic year 2014/2015 was a building year for the ITAV Alumni and Community Mentoring Program, with particular focus put on building training, including training materials, and a recruitment and tracking system, as well as recruiting mentors and mentees. The ITAV Mentoring program provides the "social capital" for students by providing support and guidance for career preparation while in college, by being matched with a mentor in their career area of interest. The ITAV Mentoring program model garnered the confidence of the Balfour Foundation, with news of a \$20,000 grant coming in June 2015, which would provide the funding to continue and expand the program in academic year 2015/2016.

The ITAV program awarded CRLS alumnae Ashley Correia and Lamia (Lily) Sater the second \$500 installments of their two-part awards upon fulfilling their enrollment requirements.

## Scholarships and Awards

As a result of concerted efforts by the FoCRLS Scholarship Committee, the scholarships offered via FoCRLS expanded significantly in 2015. FoCRLS presented a record number of scholarships this year! In 2015 we presented 24 scholarships and awards totaling \$24,700 to graduating seniors — a dollar increase of 63%. (In 2014, FoCRLS presented 19 scholarships and awards totaling \$15,600.)

All scholarship awardees must have demonstrated academic achievement, excellent character, motivation for success in college and beyond, and financial need. The scholarship applications showed the caliber of CRLS students and the depth of their aspirations, and scholarship review committee members agreed that reading the applications provided the motivation to expand the FoCRLS scholarship program even further.

And indeed, even as students were applying for 2015 scholarships, new scholarships were in the works for 2016. Spring 2015 saw the launch of the "100 by 100" Cambridge Business Community Scholarship Initiative. Outreach began in Spring 2015 for a fund of \$10,000 to be offered in Spring 2016. More details about the enthusiastic response by the Cambridge business community to this initiative can be found later in this report in a section dedicated to the launch of the "100 by 100" Cambridge Business Community Scholarship Initiative. In addition, two sponsored new scholarships were created: The Calvin Hicks Memorial Award for the Study of Music, and The Rose and Victor Rifkin Family Scholarship.

Fundraising for Friends of CRLS takes place in many forms:

## **Solicitation Letters**

For the eighth consecutive year, the major source of donations to FoCRLS were two mailed and email solicitations in December (2014 end-of-year/holiday) and in May (2015 pre-graduation). Both mailings went to the wider CRLS community: parents of students in grades 9-12, and to subsets of Cambridge homeowners, CRLS alumni, and other community supporters. An email solicitation was sent out through the Friends of CRLS listserv as well. These two seasonal solicitations drew contributions of \$57,549. Additionally, we received \$2,025 this year from last year's May solicitation, for a total of \$59,574.

A strong factor in the success of our solicitations was the help of volunteers who labeled envelopes and who participated in the FoCRLS Winter Phonathon to reinforce the message of the letter and email solicitations.

## **House Party**

CRLS parents Amy Munsat and Harry Flamm, along with other members of the host committee – Sarah Bell, Andy Eccles, Alison Field-Juma, Marguerite Hicks-Gyewu, Calestous Juma, Pattie Maes, Karl Sims, Robin Streit, Karen Tsalah, and Sally Watermulder – welcomed the community into their home for a festive afternoon to benefit FoCRLS on Sunday, May 17, 2015. The House Party, attended by a lively crowd of approximately 50 guests raised over \$4,000 for FoCRLS programs.



Besides delicious food and the opportunity to connect with CRLS parents, faculty and staff, and other community members, the afternoon featured presentations from CRLS Principal Damon Smith; FoCRLS Executive Director Elaine Schear; Marjorie Hicks (aunt of FoCRLS Board Member Marguerite Hicks-Gyewu), who announced The Calvin Hicks Memorial Award for the Study of Music; and three recipients of FoCRLS opportunities. ## **MayFair Raffle**

Under the leadership of FoCRLS Mayfair Raffle Coordinator Karen Tsalah, the 2015 MayFair Raffle Coordinators surpassed previous year totals, breaking the \$8K mark at a whopping \$8,001 dollars! The raffle again showed that CRLS students benefit when the whole community comes together. The raffle featured 64 prizes from 53 local businesses. ## <u>Fundraiser at Henry Bear's Park</u>

## The CRLS Community

The 2014/15 school year began with communication about Friends of CRLS to all CRLS families. A full-page informational insert was included with Principal Smith's "Welcome to CRLS" letter to parents, thus underwriting FoCRLS as an integral part of the school community and as an organization worth joining and supporting.

Throughout the course of the year, announcements went out in the weekly internal CRLS newsletter, Did You Know? (DYK), as well as in the emailed CRLS parents' newsletter produced by CRLS Family Liaison Greta Hardina. Flyers created to promote ITAV, Student Travel Fellowships, and Scholarships were posted on bulletin boards, distributed to appropriate representatives, and featured on the electronic bulletin boards (computer screens) in the lobbies of the main and arts buildings. Multiple requests for Faculty Innovation Grants proposals were sent to all CRLS staff through the school's email system.

While our electronic reach continued to deepen, FoCRLS maintained its belief in the value of face-to-face contact in our community. FoCRLS had tables at various CRLS events over the course of the year, and the FoCRLS office was a magnet for students and faculty alike, providing information about FoCRLS programs.

## **Community Meetings**

FoCRLS holds community meetings at CRLS twice a year - a School Year Kickoff to welcome parents at the beginning of the year and an end-of-year wrap-up, enabling CRLS parents and

other interested members of the community to come together, hear about FoCRLS activities, and find out how to get involved. Held in September and May, these two meetings framed the year. The September meeting was a lively mix of new CRLS parents and returning veterans, giving the opportunity for parent-to-parent information sharing. The May meeting was a celebratory vear-in-review, acknowledgement of our many volunteers, and an "ask the principal" session with Principal Damon Smith.

### **Business Community Engagement**

This year saw the launch of an exciting new partnership with the Cambridge business community, spearheaded by FoCRLS Executive Director Elaine Schear, the "100 by 100" Cambridge Business Community Scholarship Initiative. The goal of this initiative is to raise \$10,000 or more annually, through an annual commitment of \$100 or more from 100 or more Cambridge businesses. Response was enthusiastic, with endorsement by Cambridge Local First and the support of the Harvard Square Business Association, and initial contributions totaling \$2,500 arriving in just the first few months, with more pledges obtained. (The \$10K goal for 2015 goal was indeed met and surpassed – you'll have to wait for the 2015/2016 annual report for more details!)

What is important to note is that this has proved to not just be a fundraising endeavor; FoCRLS's growing relationship with the business community has provided us with an opportunity to learn from and explore our mutual goals and to answer the question, "What can FoCRLS give to the Cambridge business community and what can our diverse and engaged businesses give to our school? There has been great interest shown by Cambridge business owners in what happens within the walls of CRLS, and it has been a wonderful opportunity to showcase the activities of the high school of which we are so proud.




